





To prevent visual distraction and to ensure our logos have maximum impact, we need to give them the space to stand out. Therefore, a clearance area of a minimum size of 5mm must be used around the logo at all times.

All graphic, photographic and typographic elements must be kept clear of this area in an attempt to maintain the integrity of our logos.



A major part of the overall BSPD branding is the creation of a series of sub-brand logos for each of the main branches and groups within the society.

This logo must be used on any marketing materials produced by the branch or group to ensure consistency.



Social media versions of our logo have been carefully created to emphasise the hierarchy between the BSPD main account and our branch and group accounts.

The branch and group version includes the BSPD website address, so that all branches and groups direct patients to the main BSPD website.

The correct social media logo must be used on any active online accounts. Please contact the administrator to be sent the design files for the unique logo for your branch or group.

These specifications are based on the second edition of the Pantone® solid to process guide. To ensure consistency always follow these specifications.





Our typeface and typographic style is an essential part of the BSPD brand identity. Correctly used and consistently applied it will enhance, strengthen and build recognition.

Our principal brand typeface is Bariol Regular. Minimum point size is 9pt except for brochure small print where it can be reduced to 7pt if required.

For desktop applications such as Microsoft Office where Bariol is not available, Arial Regular should be used as a default font. All live text areas for electronic media such as Powerpoint and typed letters should also be typeset in Arial Regular.

Please ensure you always use a photo that best represents BSPD to the audience you are presenting to.



Accessibility is about design for everyone. The site complies with accessibility best practice and complies with the W3C's Web Accessibility Initiative (WAI) guidelines.



It cannot be used by other organisations or for commercial purposes without the express permission of BSPD.




